

NOTICE OF PUBLIC HEARING

The Boston Redevelopment Authority (“BRA”), pursuant to Article 80, Section 80D-5.4(c) and Section 80A-2 of the Boston Zoning Code (the “Code”), hereby gives notice that it will hold a public hearing on Tuesday, August 14, 2007 at 2:45 p.m. at Boston City Hall, Room 900, Boston, Massachusetts, to consider the Arnold Arboretum Institutional Master Plan filed by Harvard University (“Harvard”) on October 4, 2006, as revised on August 3, 2007 (as so revised, the “IMP”), and the issuance of an Adequacy Determination with respect to the IMP. The IMP sets forth Harvard’s plans to construct one new building—a 45,000-square-foot Research and Administration Building (the “Weld Hill Research and Administration Building” or the “Building”)—during the ten-year term of the IMP. The Building project is proposed for construction on a parcel of land in Roslindale (the “Weld Hill Parcel”) privately owned by Harvard University and bounded by Weld Street, Walter Street, Centre Street, and the Hebrew SeniorLife facility. The Building project will undergo Small Project Review pursuant to Article 80E of the Code. The IMP also outlines the proposed development controls and guidelines that will govern future development on the Weld Hill Parcel.

In connection with the IMP, the BRA Board will be requested to issue an Adequacy Determination pursuant to Article 80, Section 80D-5.4(c), and to petition the Boston Zoning Commission to approve the IMP and to approve a map amendment to designate the Weld Hill Parcel as an Institutional Master Plan Area, pursuant to Section 80D-6 of the Code. In addition, approvals are requested of the BRA pursuant to Article 80, Section 80E for the issuance of a Small Project Review Certification of Approval by the BRA, when appropriate, with respect to the Weld Hill Research and Administration Building.
